- By signing this assumption of liability, I understand that I cannot, and will not attempt to attach any type of trailer, child seat, or any other type of device to the E-bike.
- By signing this assumption of liability, I understand that I am personally responsible for my own actions, safety, and physical well being and am releasing Harbor Scooters, LLC from any and all liability whatsoever.
- By signing the assumption of liability, I understand that the use of the E-Bike is "At My Own Risk", that I am 18 years of age or older, and I release Harbor Scooters, LLC from any and all responsibility and liability whatsoever.
